Terms and Conditions

1. **Deposit:** A non-refundable deposit of up to 10% and signed contract are required in order to confirm the booking. Blue Ocean Golf Club reserves the right to release all space for re-sale if the deposit and signed contract are not received on or before the date indicated on the contract.
2. **Payment:** FULL EVENT PAYMENT, CONFIRMATION OF NUMBERS ARE DUE 3 DAYS PRIOR TO THE EVENT DATE. Payment will be processed on the credit card provided unless otherwise indicated in advance. We regret that cancellations and reductions in numbers within 3 days of the event date cannot be refunded. _____(initial)
3. **Cancellations:** Cancellations for group or tournament must be received in written form by email 30 days prior to the event. A confirmed acknowledgement of the cancellation must be noted from Blue Ocean Golf Club to ensure that cancellation charges are not applied. Blue Ocean Golf Club will allow the following attrition (not applicable to shotgun events):
 - 30 days before day of play - no charge for reduction up to 40%
 - 29 - 15 days before day of play - no charge for reduction up to 20%
 - 14 - 3 days before day of play - no charge for reduction up to 10%
 - 2 days before day of play – no refunds for reduction of total amount
4. **Rates:** If the number of players falls below 12 players, the rate will revert to the regular rack rate applicable for the tee times reserved.
5. **Taxes:** The above and other items will be taxed according to federal and provincial regulations. A **5% Goods & Services Tax (GST)**, a **7% Provincial Sales Tax (PST)** and a **10% Liquor Tax** will be applied to applicable items and services.
6. **Weather:** In the occurrence of inclement weather, the event will proceed as planned, unless the golf course management deems the course UNPLAYABLE. Management also reserves the right to limit the use of power carts during inclement weather.
7. **Dress Code and Course Rules:** Please inform all participants of our dress code - Comfortable golf shirt, pants, shorts or skort, golf shoes with non-metal spikes only. If spike replacement is required, there is a \$20 fee (plus applicable taxes). The average duration of a round at Blue Ocean Golf Club is 4 to 4.5 hours for 18 holes. All Blue Ocean Golf Club rules of conduct and the dress code must be adhered to at all times.
8. **Personalized Tournament Services:** Blue Ocean prepares personalized golf car signs and bag tags (when applicable). In order to do this, we require a player list or "draw" 72 hours in advance of the tee times. Any draw received within 72 hours will have tournament services made generic with only the group name and tee time. Changes to an existing draw within 24 hours are subject to a \$15 per occurrence fee (plus taxes).
10. **Odd Number Groups:** Incomplete group foursomes will always have singles and/or additional public/Member players added unless the group event purchases the remainder of the incomplete foursomes to remain private. If the group does not purchase the empty slots, they waive all right to privacy. _____ (initial)
11. **Food & Beverage:** No food or beverage of any kind shall be permitted to be brought on to the premises by the convener's guests or invitees. Food & Beverage requirements will follow by separate contract. All food & beverage event terms & conditions will also apply. _____ (initial)
12. **Alcoholic Beverages:** All alcoholic beverages are to be supplied by Blue Ocean Golf Club. Corkage events are respectfully declined. Anyone bringing outside alcohol onto our premises is in contravention of British Columbia laws and will be removed without refund. **Please ensure all players are aware of this important policy.** _____ (initial)
13. **Sponsorship Guidelines:** All on-course sponsorship must be approved through the Sales and Events Department prior to the event.
14. **Responsibility:** The Tournament Host assumes responsibility for the undue damage to the premises/property and is responsible for the repair and/or replacement of power carts and rental clubs in the event that these items are damaged, lost or stolen. Blue Ocean Golf Club does not assume responsibility of any merchandise or articles left at the course before, during or after the tournament. . _____ (initial)
15. **Performance:** Performance of this agreement is contingent upon Blue Ocean Golf Club being able to complete the contract without interference beyond control of management such as accidents, frost delays, acts of God, government requisitions, restrictions upon transportation of food, beverages and supplies, and other causes whether enumerated herein or not.
16. **Shotgun Tournaments:** Shotgun events are based on a field of 60 to 92 players. Tournament Hosts electing to do a shotgun event will be required to pay the full shotgun tournament buyout price. Modified or Reverse shotguns are booked at the discretion Blue Ocean Golf Club, and are subject to additional tee time charges based on the time of play.

17. **Indemnification:** "The Event Convener hereby releases, indemnifies, and saves harmless Blue Ocean Golf Resort, their officers, servants, agents, employees and others from and against all costs, losses, damages, compensation, claims, demands, actions, judgments and expenses, including actual legal expenses of every kind, description and nature whatsoever, in any way connect with or arising from the Special Event, in whole or in part, including but not limited to, any death or injury to persons or property loss or damage resulting from any acts or omissions of the Event Convener, its directors, officers, employees, agents, contractors, subcontractors and others, or that would not have occurred but for the use or occupation of the Permit Area by the Event Convener."

18. During the term of this Contract:

- a. Blue Ocean Golf Club shall use all reasonable efforts to fulfill the requests of the Customer to the best of its ability and to reach agreement with the Customer on any dispute that may arise between the parties, and
- b. The Customer shall use all reasonable efforts to conduct itself in a manner that is reasonable and polite and to reach agreement with Blue Ocean Golf Club on any dispute that may arise between the parties.

19. If, at any time prior to the date is ninety (90) days before the Event Blue Ocean Golf Club determines, in its sole opinion and discretion that the Customer is:

- a. Making requests that exceed the obligations of Blue Ocean Golf Club under this Contract and/or acting unreasonable, or
- b. Requiring Blue Ocean Golf Club to provide services or goods exceeding those, or at a price less than that, set forth in this Contract, unless otherwise agreed to by the parties, or
- c. Conducting itself in a manner that is rude or offensive to the employees or agents of Blue Ocean Golf Club, then Blue Ocean Golf Club shall have the right to terminate this Contract on five (5) days written notice to the Customer and shall on the fifth day after the date of such notice refund to the Customer any deposit or advance payments made to Blue Ocean Golf Club by the Customer.
